Organisational Change Overview

This last year has marked a transformative period for ACT Parents, formerly known as the ACT Council of Parents and Citizens Associations. We embarked on an ambitious program of organisational renewal designed to modernise our operations, enhance the way we support our members, and better reflect the needs and expectations of ACT public school P&Cs and parents and carers.

At the heart of these changes is our new [Strategic Plan](#), developed to guide us into the future with a sharper focus and clearer purpose. Our renewed vision and purpose reflect our commitment to being a more inclusive, proactive and impactful organisation. The strategy commits us to continue supporting P&Cs while creating new pathways for individual parents and carers to engage with and influence the public education system.

A key initiative supporting this vision was our Membership Model Review. The outcome was a complete overhaul of our membership structure, simplifying categories and creating more inclusive, flexible opportunities for participation. We also developed a new, more predictable fee structure, which will make it easier for P&Cs to plan their finances. The streamlined approach also reduces manual administration, allowing our office staff to focus more on direct member support. These reforms are designed to better reflect our membership's diversity, enable broader engagement, and ensure the long-term sustainability of our work.

To give effect to these changes, we updated our Constitution. This was an important governance milestone that was achieved with the support of our members. The constitutional changes formalised our broader role, our new membership categories and new voting rules.

In line with our broader purpose and strategy, we adopted a new name and visual identity. The transition to *ACT Parents* better reflects our evolving role as the representative voice for all ACT public school parents and carers. Alongside this, we launched new branding, designed to communicate our values of inclusion, empowerment, and collaboration.

Significantly, we started the process for a major technology upgrade, to replace outdated digital infrastructure with a modern member management system and a new website. Once completed these upgrades will improve our capacity to connect with members, share resources, and streamline administrative processes. Our website, developed in 2014, no longer met accessibility or

functional standards. Our redesigned digital presence will provide an intuitive, responsive, and secure platform for communication, membership, and advocacy.

Throughout the year, our commitment to consultation, transparency and member empowerment remained central. The transformation was shaped by our community and supported through regular engagement, including general meetings, direct communications, and multiple rounds of feedback.

Looking ahead, these changes position ACT Parents to deliver more targeted support, foster deeper community engagement, and advocate more effectively for public school families. They also lay the groundwork for future initiatives, including a Parent Advocacy Service.

This period of renewal has reaffirmed our belief in the power of parents to shape the future of public education. With a strong foundation in place, we are excited to continue building a more responsive, relevant, and representative organisation in the years to come.

President's report

It's been a big year of change for our organisation, and I've been proud to lead ACT Parents through it. One of the most visible changes has been our new name and refreshed look, which marks an exciting new chapter for our organisation. Over the coming months, we'll continue rolling this out across our materials and platforms, making it easier for families to recognise and connect with us.



A key moment in the past year was the ACT Election. We were proud to host a well-attended education forum featuring spokespeople from all major political parties. It gave members the opportunity to ask questions, hear policy commitments firsthand, and make informed decisions about the future of public education in our territory. We were especially pleased to see a commitment for a dedicated Parent Advocacy Service to be delivered by ACT Parents, something we have called for. While funding has not yet been allocated, we are optimistic about the implementation of this important service in the near future. It will support families to better navigate the education system and help prevent issues from arising or escalating.

This was a double-election year, with the federal election following in May 2025. We proudly promoted the wonderful P&C-run stalls held on polling day across ACT public schools. Whether it was a sausage sizzle, cake stall or mini fete, these events showcased the vibrancy of our public-school communities and the dedication of our volunteers. They also raised much-needed funds for school projects and helped build stronger connections between schools and their local communities.

Throughout the year, we continued our strong advocacy on issues that matter to public school families. We've maintained our focus on school equity, inclusive education, infrastructure and maintenance, parent engagement, and volunteer support. These are enduring priorities for ACT Parents, and we continue to bring the parent voice into important policy discussions and decision-making forums.

None of this work would be possible without our members and the many incredible volunteers who give their time to make ACT public schools even better places to learn and grow. Thank you for everything you do. Your energy and commitment inspire us.

Finally, I'd like to thank the dedicated members of our Executive Committee for their leadership and support over the past year. And of course, a heartfelt thank you to our wonderful office staff whose professionalism, insight and care ensure ACT Parent's work continues to make a meaningful impact.

The past year has been one of renewal and progress for ACT Parents, as we've strengthened our systems, deepened our advocacy, and expanded the ways we support public-school parents and carers.



Our transition to our new name and identity has been more than a rebrand, it represents a clearer, stronger voice for parents in the ACT public education system. The refreshed website and communications we are developing will make it easier for parents, P&Cs, and schools to access the information and support they need, when they need it.

Operationally, we've focused on consolidating the improvements made in recent years. Our ongoing technology and record management reforms are delivering tangible benefits, creating a more responsive, efficient and transparent organisation. These changes ensure that as the needs of our members evolve, ACT Parents remains agile and well equipped to meet them.

Member support has continued to grow in both volume and complexity. Parents and P&C volunteers increasingly seek advice that blends practical governance support with an understanding of the relational and systemic issues they face. From constitutions and canteens to conflict resolution and collaboration with school leadership, the issues are varied, but the goal is always the same: to help parents feel confident and supported in shaping their school communities.

This year also saw significant activity in our advocacy and representation. We contributed to consultations on topics including literacy and numeracy, student wellbeing, disability inclusion, and the future of school infrastructure. Our engagement with the ACT Education Directorate, the Minister, and other sector partners remains strong and constructive, ensuring that parents' insights inform decision-making at every level.

A particular highlight was our ACT Election Forum, which gave parents a rare opportunity to hear directly from education spokespeople from all major parties. It was also encouraging to see the commitment to trial a Parent Advocacy Service, a long-standing ACT Parents priority that will help families navigate the education system and resolve issues early.

Behind the scenes, our small but dedicated staff team has continued to deliver high-quality support to members while managing competing demands and tight timeframes. I am deeply proud of their professionalism, adaptability, and shared commitment to our mission.

As we look to the year ahead, our focus will remain on strengthening our organisational capability, expanding our reach, and building a culture of inclusion and collaboration across all levels of our work. Together with our Executive Committee, members, and partners, we will continue to empower parents and shape a stronger, more equitable public education system for every child.

Our current Executive Committee was elected at the Annual General Meeting on 5 November 2024. The Executive Committee is responsible for the governance and strategic leadership of ACT Parents. They play a vital role in guiding our representative work and ensuring we deliver meaningful support to members across the ACT public school system.

Throughout the year, Executive Members represented ACT Parents at key meetings with decision-makers in education, including:

- The Senior Executive Team of the ACT Education Directorate
- The ACT Branch of the Australian Education Union

These conversations ensure that parent voices are part of the decisions shaping our schools.

Highlights from 2024–25 include:

- Holding nine Executive Committee meetings to oversee operations and set strategic priorities
- Meeting all governance and funding obligations, maintaining strong organisational accountability
- Driving major reforms, including the development of our new Strategic Plan, modernised membership model, new name, and refreshed branding—laying the foundation for a future-ready and inclusive parent organisation
- Celebrating our incredible P&C volunteers during National Volunteer Week 2025 with a special networking event

In March 2025, ACT Parents was honoured with a Canberra Gold Award, recognising our long-standing commitment to public education and parent engagement in schools. Presented by the Chief Minister, the award celebrates individuals and groups who have called Canberra home for 50 years or more and have made a lasting contribution to the community. Executive and life member Vivienne Pearce OAM accepted the award on behalf of our organisation.

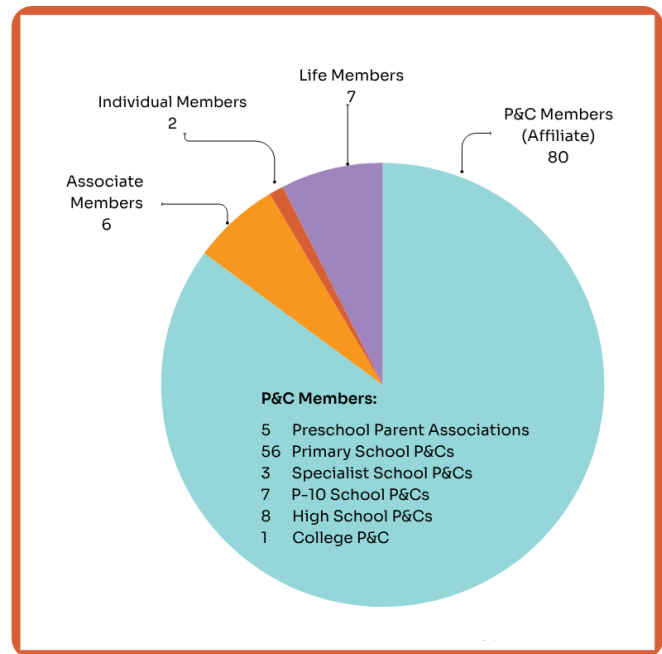

ACT Parents works in partnership with a range of external stakeholders to help strengthen the ACT public education system. We value the diversity of perspectives our partners bring, which enhances our advocacy and ensures we remain a strong and informed voice for parents and carers across public school communities.



ACT Education Directorate

Our relationship with the ACT Education Directorate continued to deepen in 2024–25, with regular formal meetings, active participation in consultations, and strong collaborative ties with key staff. This year, ACT Parents contributed to several strategic stakeholder groups, including the Disability Education Reference Group, the Strong Foundations Implementation Partners Group, the Safe and Schools Taskforce Advisory Group and the Allied Health Review, helping to shape policy and practice in critical areas.

We appreciate the financial support provided through the annual grant administered by the Directorate. This funding underpins our work and enables us to continue delivering high-quality services and advocacy for public school families.

Australian Council of State School Organisations (ACSSO)

As a member of ACSSO, the national peak body for parents in government schools, ACT Parents plays an important role in ensuring the views of ACT families are heard on national platforms. We contribute to ACSSO through board and general meeting representation, as well as by offering insight and analysis for national consultations. This partnership helps elevate the voices of ACT parents in federal education policy conversations.

Australian Education Union (ACT Branch)

ACT Parents met with the Australian Education Union (ACT Branch) throughout the year to discuss shared priorities and emerging issues across the education system. These conversations provide a valuable forum for exchanging perspectives and deepening mutual understanding between our two organisations.

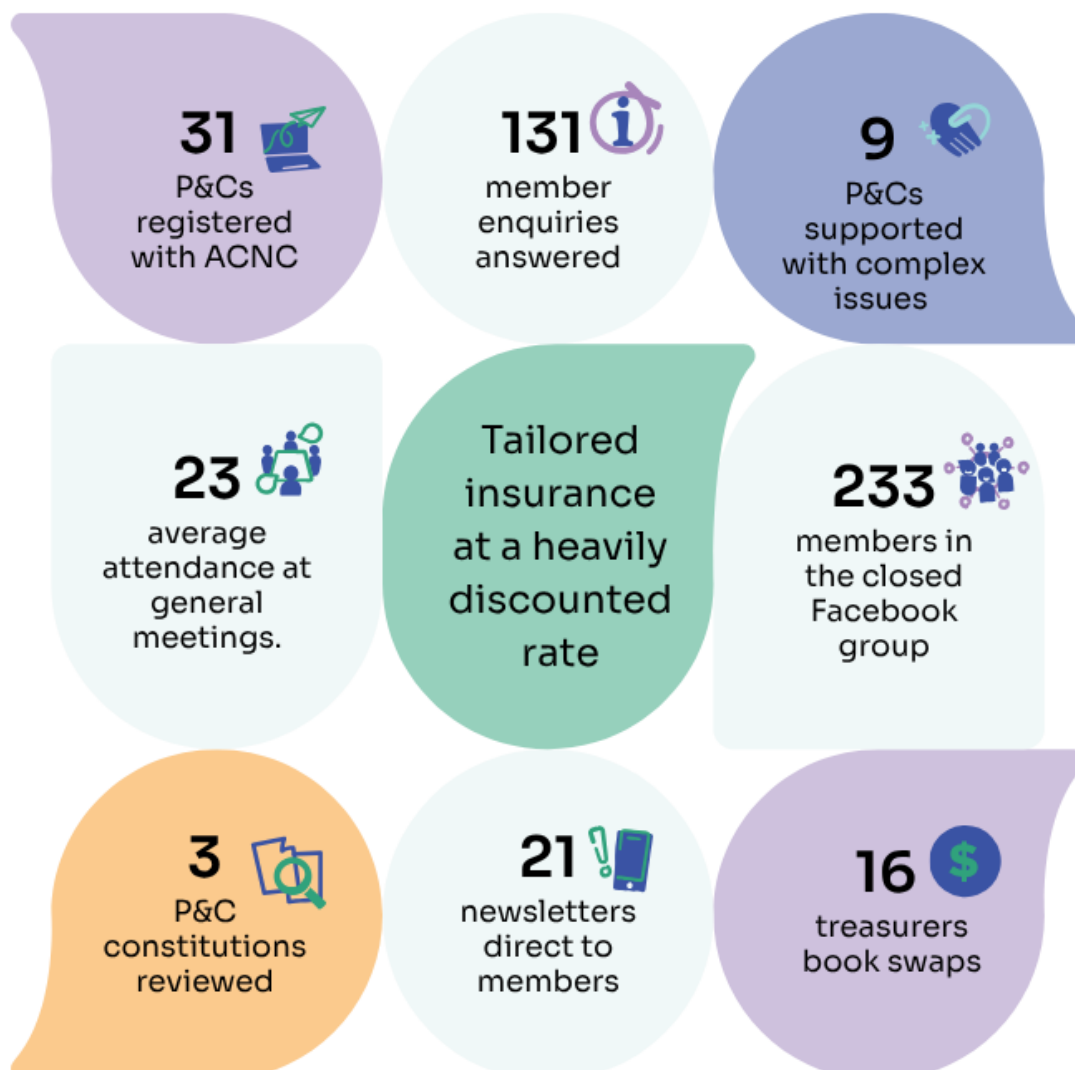
This year, we shared parent views on a range of key topics including workforce and staffing challenges, school infrastructure, and inclusive education. These exchanges help inform our advocacy and ensure that our engagement with members is grounded in a broader understanding of the education landscape.

Canteen Stakeholders

Supporting healthy and sustainable school canteens remains an important focus for ACT Parents. We work alongside ACT Health and Nutrition Australia to stay updated on school food environments and support P&Cs managing public school canteens. Our involvement in the Collaborative Working Group on Food at School keeps us across emerging issues and enables us to advocate effectively on behalf of volunteers and canteen managers.

Supporting P&Cs to Thrive

Member services and supports up close



Assisting members

ACT Parents continues to provide comprehensive support to help P&Cs run effective, compliant, and confident associations. Through practical resources, tailored guidance, and strong connections, we empower P&Cs to thrive and contribute meaningfully to their school communities.

Targeted Member Support

One of our most valued services is our advice line. Members contact us with questions about running their P&C, managing services, or meeting compliance requirements.

Not every enquiry is straightforward. Some issues take time, careful research, and collaboration to resolve. Members tell us it's reassuring to have someone who listens and helps develop a practical course of action.



- Rebuild committees and improve engagement
- Resolve internal conflicts
- Decide the viability of operating services like canteens or OSHC
- Meet regulatory obligations
- Strengthen school–P&C relationships

A major project this year was supporting P&Cs to register with the Australian Charities and Not-for-profits Commission (ACNC) following changes to Australian Taxation Office (ATO) policy. These changes meant that not-for-profits with a charitable purpose and an ABN could no longer self-assess for income tax exemption.



ACT Parents liaised directly with both the ACNC and ATO, fielding member questions and coordinating a bulk registration process. This nine-month project involved three rounds of applications and resulted in 31 P&Cs successfully registering by the 31 March 2025 deadline, bringing them into line with regulatory requirements and simplifying future reporting.

Building Member Engagement & Community

Fostering Collaboration and Connection

Our members continued to engage actively through ACT Parents events, meetings, and social media. The closed Facebook group for P&C leaders and members now has 233 members and remains a lively space for sharing successes, seeking advice, and connecting with fellow members.

During the year, members made 64 posts to exchange equipment, share ideas, seek or give recommendations, and discuss ways to increase family engagement in P&C activities.

ACT Parents also:

- Highlighted member activities on social media and in local media, especially election-day fundraising BBQs.
- Hosted a National Volunteer Week Celebration during the May general meeting to thank P&C volunteers and recognise achievements.
- Gave members direct access to ACT election candidates at the Public Education Election Forum, featuring speakers from major political parties.



- Introduced interactive tools like *Slido* during meetings to gather real-time feedback, inform advocacy priorities, and foster open discussion among members.

General meetings

Our general meetings remain an important forum for members to connect, raise issues, and influence ACT Parents' direction. In 2024/25 an average of 23 members attended each meeting, with discussions covering topics such as:

- Parent Portal and personal data
- School infrastructure
- In-school music programs.
- The future of school canteens
- Students access to toilets
- Public education asks for the ACT election
- ACT Parents resources for P&Cs
- Health promotion programs in schools.
- Outcomes for public education from the 2025/26 ACT Budget
- ACT Education Directorate corporate sponsorship policy.
- Addressing bullying in schools



We also welcomed the valuable insights of speakers from:

- The School Safety Team, Transport Canberra, on how P&Cs can raise transport, infrastructure and safety concerns of their school community.

- The Infrastructure and Planning Team, ACT Education Directorate on the strategic and policy environment guiding infrastructure planning and maintenance.
- The Digital Technology team from the ACT Education Directorate the parent portal implementation.

Shaping the future together

This year, members played a central role in shaping ACT Parents' transformation. Through general meetings and consultations, members helped steer key milestones, including changing our name and updating the constitution to reflect broader membership categories that support more effective advocacy and organisational sustainability.

We thank members for their trust, engagement, and collaboration in this once-in-a-generation renewal of our organisation.

Publications and Digital Presence

Fortnightly Newsletter – ACT Parents Update



Our fortnightly electronic newsletter, Communicator, continues to be a key channel for reaching our members with timely updates, reminders, and practical advice. With just over 1,000 subscribers, the newsletter offers valuable content tailored to the needs of P&C associations and individual parents across the ACT.

In 2024–25, we published 21 issues, featuring news on advocacy work, policy updates, operational tips for P&Cs, and resources to support stronger school communities. Reader engagement, tracked through MailChimp analytics, shows steady year-on-year improvement in both open rates and click-throughs, reflecting the relevance and usefulness of the content we deliver.

Website

Our website remained a trusted resource hub for members throughout the year. High-traffic sections included our template library, which helped streamline P&C operations and improve administrative confidence for volunteers.

As we prepare for the launch of a brand-new website, we have begun to retire outdated content to make way for refreshed, user-friendly, and accessible resources. This redevelopment reflects our commitment to providing digital tools that are not only functional but also responsive to the evolving needs of our members and the broader public school parent community.



Facebook

The ACT Parents Facebook page continued to grow in reach and engagement, with 1.6K followers during the reporting period (1 July 2024 – 30 June 2025). Our social media presence plays a key role in real-time communication, community-building, and amplifying the parent voice on local education matters.



This year, our Facebook post highlighting concerns about the \$11 Working With Vulnerable People (WWVP) registration fee for volunteers struck a chord with the community. The post, which called out the unfairness of placing financial barriers on school volunteers, received 8,836 views and 183 interactions, and helped rally support for a petition urging the government to reconsider the fee.

Overall, our Facebook engagement increased by 4.6%, with a 4.1% rise in content interactions, reflecting a growing appetite for advocacy updates, practical resources, and recognition of the important work done by parents and carers in public schools.

Mobilising Parents for Impact

Transition to School Parent and Carer Webinar

On 12 September 2024, ACT Parents in collaboration with the ACT Education Directorate co-hosted a free webinar to support families preparing for their child's transition to preschool or kindergarten in 2025. Over 200 people registered to attend the event which featured Educational Transitions Researcher Dr Kathryn Hopps and members of the ACT Education Directorate's Early Years Pedagogy Team.



The webinar offered practical strategies and insights to help families navigate this important milestone, covering topics such as the role of strong transitions in supporting learning and development, what to expect in the early years of school, building children's confidence, connecting with school communities, and accessing further support and resources.

Calls for a Parent Advocacy Service

Through strong media coverage on a range of topics this year, ACT Parents' profile has grown significantly. As a result, we saw an increase in contact from non-members, parents and carers in the public education system, seeking support to help resolve issues affecting their child's school experience.



Many of these enquiries related to school safety, student wellbeing and inclusion, as well as broader system issues such as complaints handling and enrolment policies.



These conversations show that families want their voices heard. Many parents are turning to ACT Parents as a trusted organisation to help them navigate the public education system and advocate on the issues that matter most to their families. This growing demand has strengthened our case for establishing a Parent Advocacy Service to meet this demonstrated need within the community.

Positively Influencing Policy









ACT Parents is committed to being a strong, credible voice for public school families across the ACT. We advocate on behalf of both individual parents and P&C associations, sharing their insights and lived experiences with decision-makers.

From classrooms to canteens, school infrastructure to school transport, we provide input across all aspects of the public-school experience. Our goal is to ensure that parent perspectives are not only heard, but meaningfully considered in shaping policies, programs, and school life.

Key Achievements in 2024–25

Over the past year, ACT Parents has continued to champion the voices of public-school families across the ACT. Through advocacy, representation, and community engagement, we have worked to shape better outcomes for students, parents, and carers. Some of our key achievements for the 2024–25 financial year include:

Raising Parent Voices in the ACT Election

In the lead-up to the 2024 ACT Election, ACT Parents hosted a well-attended Election Forum, bringing together education spokespeople from all major political parties. This important event gave parents the opportunity to hear directly from candidates about their plans for public education and to ask questions on the issues that matter most to families.

As a result of our sustained election advocacy, we successfully secured a commitment from the Labor Party to support the establishment of a Parent Advocacy Service, a service designed to help parents navigate the education system and have their voices heard.

Strong Policy Contributions

ACT Parents played an active role in shaping education policy at both the territory and federal levels. This included:

- Preparing a detailed submission to the Commonwealth Better and Fairer Schools Bill, advocating for needs-based, equitable funding for public schools in all states and territories.
- Providing input into the ACT Board of Senior Secondary Studies (BSSS) Strategic Plan, ensuring parent views were included in the long-term planning for senior secondary education.
- Contributing to the ACT Legislative Assembly Inquiry into the Rollout of MyWay+, voicing concerns and feedback about the impact on students.



Advocacy That Makes a Difference

We mobilised our members to participate in a campaign opposing the introduction of a proposed \$11 fee for Working With Vulnerable People (WWVP) registration for school volunteers. Through a widely shared social media campaign, we successfully helped stop the introduction of the fee, removing a potential barrier to volunteer participation in schools.

Representatives on Government and Community Committees

ACT Parents appoints elected parent representatives to a wide range of ACT Government and community committees. These representatives ensure that the voices of parents and carers are present in important conversations, contributing perspectives grounded in real-world experience. Their involvement strengthens decision-making by bringing a parent lens to policies, programs and initiatives that impact public school communities.

Community Insights to Inform Policy

To guide our policy development and advocacy, we conducted several targeted surveys throughout the year. These included:



- Parent and P&C election experience surveys at both the 2024 ACT and 2025 Federal Elections
- A survey on fundraising experiences, highlighting the challenges and successes of school-based fundraising efforts
- Feedback on the complaints process in ACT public schools, helping inform our call for systemic improvements
- A survey on corporate sponsorship, exploring parent views on commercial partnerships in schools

These insights continue to shape our advocacy priorities and strengthen our ability to represent the lived experiences of parents and carers.

Representation in Media

In 2024–25, ACT Parents continued to be a visible and influential voice in the media, representing the interests of parents, carers and P&Cs across the Territory. Over the course of the year, we featured in 55 media stories, ensuring parent perspectives were included in public dialogue on a range of education and community issues.



Key topics covered in the media included election day fundraisers, traffic and parking concerns around schools, and broader questions of safety and infrastructure. Through these appearances, ACT Parents helped raise awareness and drive conversations about the everyday challenges and successes experienced by public school communities.

We also supported local P&Cs to share their views on important school-level matters, such as playground upgrades and road safety improvements, amplifying the voices of parents on issues that directly affect their children's learning and wellbeing.

Throughout the year, ACT Parents issued six media releases to proactively shape public discussion and advocate for meaningful change:

ACT Parents receives an annual grant from the ACT Education Directorate to deliver our core purpose, supporting P&Cs, representing parents and carers, and promoting parent engagement in public education. For the 2024–25 financial year, the grant amount was \$250,567.

Additional income was generated through one-off grants, interest, and the modest membership fees collected from P&Cs, totalling \$39,184.

As in previous years, the largest expenditure was wages. Rising employment costs and growing operational demands have continued to drive this increase.

During the year, ACT Parents made a significant investment in modernising its systems and services following several years of planning. This included the membership model review, initiating the development of a new member management system, and the creation of a new website to better connect and support members.

ACT Parents expenditure remains aligned with the priorities outlined in our Strategic Plan and consistent with the objectives of the ACT Education Directorate Deed of Grant.
